Bill Shaddock

Chief Executive Officer

Bill Shaddock is the founding partner of the Shaddock Law Firm, and is an attorney admitted to practicelaw since 1977. He received his B.B.A. in Finance from Texas Christian University in 1973, and his M.B.A. in Real Estate from Southern Methodist University in 1974. Shaddock then went on to earn his J.D. from Baylor University School of Law, during which time he attended a Summer Law Study Program at Oxford University, in Oxford, England, and completed a clerkship at the U.S. Securities & Exchange Commission. Shaddock began his legal career in 1977 with the law firm of Turner, Hitchins, Webb, McInerney, Hartnett & Strother where he focused on business-related trials, general corporate work and real estate transactions until 1983.

Over the next two and a half decades, Mr. Shaddock concentrated on real estate development and settlement services, creating the largest Fee Title Network in the State of Texas from 1987 to 2006, and ultimately building a real estate empire that includes Shaddock Development Company (most notable developments: Willow Bend and Stonebriar), Capital Title of Texas, Willow Bend Mortgage, Shaddock Law Firm, and most recently First National Title Insurance Company (a top 25 nationally ranked underwriter), and Capital National Financial, Inc. (offering national title insurance services). In addition to his professional accomplishments, Shaddock has earned numerous business and humanitarian awards for his business acumen and selfless work for the Dallas community and his alma maters.
